

1798.150	<p>Civil action</p> <p>Any consumer whose non-encrypted or non-redacted PI is subject to unauthorized access and exfiltration, theft or disclosure (because the organization violated its duty to secure) may institute a civil action.</p>	<p>Simplifies responses to litigation claims via automated e-discovery.</p> <p>Empowers legal and compliance teams with easy-to-use tools that don't rely on IT involvement and deliver legal investigation data within minutes.</p>
